2015 YEAR IN REVIEW

We are pleased to share with you just a few highlights of our work in 2015

IN FEBRUARY, we launched our multi-year data project aimed at the three biggest challenges standing between us and a cure: disease prediction, disease progression and care delivery. This transformative project will speed the path to a cure and save lives.

IN JUNE, we teamed up with the United Methodist Church to launch an effort to mobilize people of all faiths in the fight against Alzheimer's disease. The coalition supports families; promotes dignity, compassionate care and quality of life for individuals; and calls on leaders to work for a cure.


> **IN JULY.** at the White House Conference on Aging, the Dementia Friendly America Initiative announced five pilot communities. There we helped launch the effort to help communities around the country create a supportive environment for people with Alzheimer's and their caregivers.

IN AUGUST, the Patient-Centered Outcomes Research Institute (PCORI) approved UsAgainstAlzheimer's, the Mayo Clinic, UCSF's Brain Health Registry and the University of Florida for a contract to speed the search for an Alzheimer's cure.


This groundbreaking project is the first-ever Alzheimer's- and dementia-focused patient- and caregiver-powered research network.



IN MARCH, we joined leaders from 80 countries and experts and advocates at the First World Health Organization Ministerial Conference on Global Action Against Dementia in Geneva. Development of an effective treatment by 2025 and improvement in the capability and quality of dementia support systems are now front and center on the global agenda.

IN OCTOBER, WomenAgainst Alzheimer's joined with the Women's Brain Health Initiative Canada, Alzheimer's Research UK and 21st Century BrainTrust® to form the Global Alliance on Women's Brain Health. We'll be working to raise awareness about sex disparities in research and expand funding for sexbased brain health research.

IN DECEMBER, Congress passed a nearly 60% increase in funding for Alzheimer's research through the National Institutes of Health, which came as a culmination of months of work. Thousands of our advocates and supporters made phone calls and signed petitions. Total public research funding is now almost \$1 billion per year.

IN NOVEMBER, our Alzheimer's Talks featured Dr. Larry Goldstein from the University California. San Diego. of He described groundbreaking research on stem cells and offered a glimpse of potential future therapies and treatments for Alzheimer's disease using stem cell technology.


OUR NETWORKS AND COALITIONS

ActivistsAgainstAlzheimer's

forged a powerful relationship with patientadvocate and author Greg O'Brien. We launched partnerships with assisted living providers for advocacy, clinical trial engagement and care best practices and continue to grow our social media presence for activists across the country.

AfricanAmericansAgainstAlzheimer's

worked with the Alzheimer's Disease Research Centers in Atlanta, Chicago, Indianapolis, Houston and Tampa where we presented the play Forget Me Not, provided national local information, and recruited and AfricanAmericansAgainstAlzheimer's members and Brain Health Registry (BHR) volunteers. We reached 3,800+ people, doubled our membership and provided BHR with 700+ volunteers.



WARD-WINNING STAGE PLAY

ClergyAgainstAlzheimer's

launched an exciting partnership, the Faith United Against Alzheimer's Coalition, with the United Methodist Church. The Network's Seasons of Caring book has sold 1,300 copies and received the 2015 Caregiver-Friendly Award.

LatinosAgainstAlzheimer's

grew its stakeholders to a network of 30+ Latino-serving organizations, community leaders, health experts and policymakers. Through training and mobilization, we empowered diverse patients, caregivers, and LatinosAgainstAlzheimer's Coalition members to successfully advocate for a 60% increase in Alzheimer's research funding. We hosted Congressional Hispanic Caucus meetings on UsAgainstAlzheimer's Alzheimer's Beneficiary and Caregiver Support Act and secured key support of Latino legislators.

ResearchersAgainstAlzheimer's

completed an important white paper and held an expert webinar on the path to 2025, to become an authoritative source on Alzheimer's research. In 2016, ResearchersAgainstAlzheimer's will develop the first-ever drug pipeline report, to be released with validation from scientists and accessible to mainstream press.

WomenAgainstAlzheimer's

hosted our annual Summit, which included a strong Capitol Hill day and the *Out of the Shadows* dinner, which raised more than \$450,000. We launched the "We Won't Wait" campaign and plan to collaborate with a growing list of partners including Caring.com, Lotsa Helping Hands, Women's Heart Alliance and Hadassah in our 2016 work.

DIGITAL ADVOCACY

No public health movement can succeed without a broad, energized base of supporters. The battle to end Alzheimer's is no different, which is why we've built our own "Digital Army." Across Facebook, Twitter and email, UsAgainstAlzheimer's leads more than 190,000 online activists who, in 2015, donated more than \$200,000 and generated nearly 31,000 petition signatures successfully demanding increased federal investment in National Institutes of Health research. This substantial digital footprint also serves as a megaphone through which we can reach a larger audience and help reduce the public stigma around Alzheimer's. This growing "Digital Army" is at the heart of our mobilization and advocacy strategy.

RESEARCH!AMERICA'S PRESTIGIOUS GORDON AND LLURA GUND LEADERSHIP AWARD

We are pleased to announce that George and Trish Vradenburg will receive Research!America's prestigious Gordon and Llura Gund Leadership Award for their work to end Alzheimer's. The 20th annual Research!America Advocacy Awards will be presented in person to all the recipients at the 2016 Advocacy Awards Dinner on March 16, 2016 in Washington, DC.

In his nomination letter, Dr. Husseini K. Manji, Global Therapeutic Area Head, Neuroscience, Janssen Research & Development, LLC wrote:

George and Trish are tireless in their crusade against Alzheimer's, which they have made their life's work. Rather than simply funding business as usual, they have worked to shake up Congress, the research community, industry, investors and fellow advocates. Their disruptive approach has honed in on overcoming key impediments to developing and delivering disease-modifying Alzheimer's therapies as quickly as possible. Since they founded UsAgainstAlzheimer's five years ago, Congress has given a 30 percent increase to the NIH for Alzheimer's research funding. George and Trish see Alzheimer's as a global threat that calls for global solutions. They have worked at that level to engage governments, international organizations, NGOs, research institutions and others in action-oriented collaboration and to obtain resource commitments from public and private sources. They are driving innovation in Alzheimer's care and caregiving to improve life for patients and caregivers alike, and they have inspired countless others to join their collaborative quest.





CONVENED COALITIONS AND ENTERPRISES



The Global Alzheimer's Platform (GAP)

- Secured \$3.45 million in start-up funding, plus in-kind executive management support from Eli Lilly and Janssen Pharmaceuticals, for this game-changing initiative
- Through public-private partnerships, created the GAP Registry, GAP Cohort and GAP-Net, which has enlisted 11 of ultimately 30 certified Alzheimer's clinical trial sites
- Secured foundational collaborations with the Alzheimer's Disease Patient- and Caregiver-Powered Research Network/Galaxy, University of Southern California-Alzheimer's Therapeutic Research Institute, Brain Health Registry (University of California, San Francisco) and Landis Communications



The Global CEO Initiative on Alzheimer's (CEOi)

- Launched the Alzheimer's Big Data Constellation with Optum Labs and four pharmaceutical companies, with \$700,000 in seed funding, to bring new analytical tools to bear on some of the biggest challenges standing between us and a cure
- Secured strong U.S. government interest and European and Canadian government support for its push for conducting clinical trials faster and at lower cost
- In 2016, will launch The Lausanne Dialogues, a year-long process of convenings and webinars to bring solutions to regulatory and access challenges that impede innovative Alzheimer's medicines




Together with the Mayo Clinic, University of California, San Francisco (Brain Health Registry) and University of Florida, and supported by a grant from the Patient-Centered Outcomes Research Institute (PCORI), we are developing the first Alzheimer's Patient-Powered Research Network, of which our Board member Meryl Comer is the Co-Principal Investigator. Through this work, we have created Galaxy—a virtual research-ready hub consisting of individuals, families, patients and caregivers bringing together 37 Research Partner Organizations and delivering a diverse patient/caregiver voice by serving as the point of engagement on PFDD (patient-focused drug development) platforms.



The LEAD Coalition now has 80 member organizations and collaborates with another 60 or more. Its 2015 growth spanned all major metrics: sign-on letters, social media followers, e-newsletter circulation, meeting participation and revenue (at 120.8% of budgeted goal). LEAD played a major role in shaping Alzheimer's provisions in the 21st Century Cures Initiative legislation and securing provisions to increase National Institutes of Health (NIH) and Food and Drug Administration funding; advocating for increased funding for dementia research across NIH; and creating a path toward a dementia care and services research summit.

POLICY UPDATE

In late December, Congress passed a 2016 omnibus appropriations package with a \$350M bump for Alzheimer's research at National Institutes of Health (NIH). This moves FY16 NIH funding for Alzheimer's to \$936M, vs. \$448M in FY 11 (more than doubled in five years). Senators Stabenow and Moore-Capito agreed to advance a support benefit for informal caregivers of Medicare beneficiaries with Alzheimer's/dementia, and Representative Roskam is interested in the House.

UsAgainstAlzheimer's continues to encourage congressional members to co-sponsor Senator Roger Wicker's EUREKA ("Ensuring Useful Research Expenditures is Key for Alzheimer's") Act. The legislation is focused on attracting bold new ideas to end Alzheimer's through research-based prize competitions. It would authorize the Director of the NIH to work with other federal agencies to establish prize challenges to reach research milestones.

Published by ClergyAgainstAlzheimer's, an UsAgainstAlzheimer's Network, Seasons of Caring includes writers who draw on their years of experience to offer words of hope, encouragement and understanding to those who are now on this journey, and to give voice to the unique challenges confronting Alzheimer's and dementia caregivers. We are honored to include the artwork of Lester E. Potts, Jr., created while he was a client at Caring Days Adult Dementia Daycare Center in Tuscaloosa, Alabama.

ALZHEIMER'S TALKS

Our monthly teleconference series continues to thrive—working to raise awareness about issues, unite advocates with researchers or policy leaders, and recruit more supporters. These informational interactive calls provide caregivers, researchers, nonprofit leaders, government officials, and other advocates direct access to the nation's leading researchers in Alzheimer's disease. In 2015 we hosted 12 teleconferences resulting in almost 15,000 new supporters for UsAgainstAlzheimer's.

Third Annual *Out of the Shadows* Summit and Dinner

In September, WomenAgainstAlzheimer's hosted their third annual *Out of the Shadows* Summit which brought together experts, advocates and lawmakers from across the country to share the latest research and urge Congress to fully fund the search for a cure.

The highlight of the summit was the annual *Out of the Shadows* dinner held at historic Union Station and featuring Maria Shriver, NPR's Diane Rehm, author and restaurateur B. Smith, and Senators Barbara Mikulski and Elizabeth Warren. The dinner raised more than \$440,000 for our work.


UsAgainstAlzheimer's is a 501(c)4 organization that engages in public advocacy, federal relations, grassroots activity and voter education.


